

Town of Clarno
Monthly Business Meeting
May 18, 2022

Chairman Tracy Signer called the Town of Clarno monthly business meeting to order at 1:00 p. m. at the Clarno Town Hall.

Chairman Signer called for roll call of Town of Clarno Officer's: Tracy Signer, Ron Brandt, Collin Nack, James Rutledge and Jackie Boss.

Also Present: Randy Voegeli, Todd Hasse of Hasse Survey, Troy Bader, and Joe Crubaugh.

The minutes from the April monthly business meeting minutes were reviewed and approved.

The agenda was approved.

Town of Clarno Assessor: No Report.

Town of Clarno Planning Commission:

- Todd Hasse of Hasse Survey met with the Clarno Town Board regarding the preliminary Plat of the Bader Field Stone Subdivision off Jeffrey and Asmus Roads. Discussion took place on the construction of Tall Grass Lane and Briar Lane. The Town of Clarno would be willing to construct the two roads. The price range that the Township suggested is less because of being a municipality.
- The Town Board also discussed the following. Regarding the Field Stone Subdivision roads. The Town Board will be meeting soon with the Bader Family for discussion regarding how the Bader family will be reimbursing the Township for the construction of Tall Grass and Briar Lanes.
- The Town Board instructed the Town Clerk to draft a letter to the Town of Clarno Building Inspector Scott Jelle, that due to lack of communication, with the Town Board, he will have to be replaced.

Large Scale Livestock Study Committee: No Report.

Town roads building and equipment:

- Township Highway man, Randy Voegeli reported on the following: Tschudy,

Melvin, Bethel, and Woodman roads have been paver patched. The rest of the Township Roads are on hold until the County completes the construction of Highway 11.

- A brief discussion on purchasing a spare tire for the mower. The approximate cost of the tire is \$280.00. No action taken.
- Township Highway man is still having trouble with traffic coming through the road he has marked as closed. Because of working with the heavy equipment and chain saws. Next time it happens he will call the Sheriff's Department.
- Supervisor Nack stated if less than three hundred feet of riff raff were placed on Honey Creek at Melvin and Franklin roads. DNR approval would not be needed.
- Town Board discussed purchasing a 6130R John Deere from Sloan Equipment for the price \$110,000. The trade in value for the Township tractor is \$16,000. Supervisor Nack made a motion to purchase the tractor. Supervisor Brandt seconded the motion.

Recycling and Waste Disposal: No Report.

Treasurer's Report was read and approved.

Monthly Bills were reviewed: Chairman Signer motioned to pay all the monthly bills. Supervisor Nack seconded the motion. The motion was approved.

Being there was no further business Supervisor Nack motioned to adjourn at 2:55 p.m. Chairman Signer seconded the motion. The motion was approved. The June monthly business meeting will be held on the 22th, at 1:00 p.m.
